#### Resolution & Order No. 2024-373:

This is a Resolution and Order to approve an IGA with the City of Albany. In 2019, the City of Albany applied for a Homeland Security Grant under Linn County Emergency Management, for a water purification trailer. This IGA clarifies that the City of Albany will house and can utilize the water purification trailer for the needs of the City of Albany. The IGA authorizes Linn County to utilize the water purification trailer for emergency needs in other communities outside of Albany.

#### Resolution & Order No. 2024-377
