R&O 2024-383: 2025-2027 Federal Section 5310 Funds

The Linn County Transportation Advisory Committee (TAC) respectfully forward these recommendations of Federal Section 5310 Transportation funds for the 25-27 biennium for the Linn County Board of Commissioners approval.

There are two grants for Federal Section 5310 dollars, Small Urban and Statewide Block Grant (STBG). The TAC held a public meeting on 10/22/2024 to review applications and make recommendations. Recommendations are as follows:

5310 Small Urban \$335,026-

5310 Funds are eligible to be used for preventative maintenance (PM), capital needs, purchased service, dispatch and asset management software, mobility management, and administrative cost of managing a project. The match rate for these funds is 10.27% and 20% depending on type of usage. The majority of match for 5310 funds is leveraged by the recipient from STIF dollars.

It is respectfully requested that the Linn County Board of Commissioners approve the recommendations of the Linn County Transportation Advisory Committee and that these award amounts be reflected in the Linn County Federal Section 5310 application to be submitted to ODOT by the Linn County Special/Rural Transportation Coordinator on or before November 20th, 2024.
